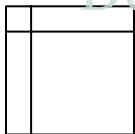
Mother Breast Feed Equal With Water Of River



Proper Oxygen For Body Get From Water

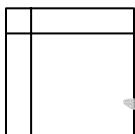


Do n't Through Garbage In To Yamuna

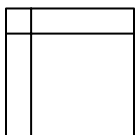
