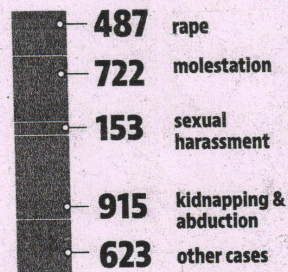
Respected Sir/Madam,

1. With Ref. to our letter dated 01/01/2013 having Ref. No.- Ref. No: - NF /SUGONW /37624-46/ 2013 the reason govt. not intimate of asking not do like that we have suggested. Our purpose was to follow up USA system and give benefit those NGO formed for social benefit. The Govt. should recognize that NGO and associates with them by providing work with support of the NGO workers and paid them salary . The control of every work should nominated by a board in which some persons of Govt. and others some of NGO body control these work. For these systems the real development of country may happen but in India some political leaders and companies form NGO where political leaders receive Govt. funds and the company CSR funds carry to theirs NGO and corruption created and as a result no development made only increase corruption. ## Women not safe in Capital

A look at some of the cases of crimes against women reported from Delhi this year



### PAST CASES

**April 13, 2018:** A PhD student of Jawaharlal Nehru University (JNU) filed a case and accused a professor of the university of allegedly molesting, threatening and sexually harassing her.

**April 10, 2018:** A 32-year-old man was arrested for allegedly raping a married woman after threatening to leak her objectionable videos. The video of the woman was recorded by another man who too had allegedly raped her last year.

**March 20, 2018:** A three-and-half-year-old girl was raped allegedly by her 22-year-old neighbour in east Delhi's Trilokpuri.

**March 16, 2018:** Eight students of Jawaharlal Nehru University (JNU) filed separate cases against a professor and accused him of allegedly sexually harassing them.

**March 15, 2018:** A 12-year-old girl was allegedly molested and then raped by her neighbour at her home in south Delhi's Mahipalpur.

**March 4, 2018:** A 22-year-old Delhi University (DU) student filed a case against her private tutor accusing him of raping her at a hotel in Gurugram and making mobile videos of the act.

We have requested to solve domestic matters of Delhi by Navjivan Foundation as a result fear of police decrease by people and pressure of work decrease by DP. We request to Commissioner of Police for his comment & Ministry Of Home Affairs also without defense.

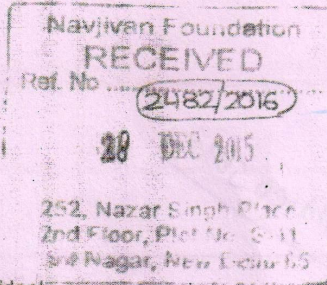

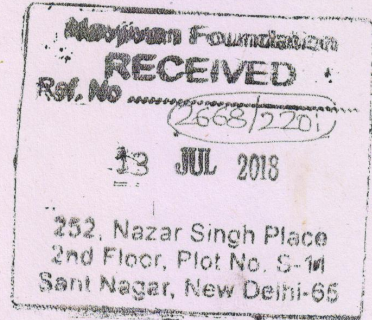


